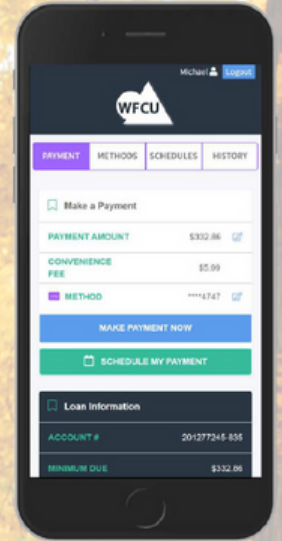


## Introducing Message Pay

Making a loan payment has never been easier! Safely make a payment to your WFCU loan(s) from an external account with Message Pay.

With Message Pay, you will receive a text message\* including the amount due on your loan with a link that directs you to the payment portal. You'll be able to see your loan(s) and you will be able to select your external preferred payment method. Please note: You will need to verify your account upon first use of Message Pay.
